: acting as Vice-Chancellor on behalf of **UNIVERSITI SAINS MALAYSIA**, located at Level 6, Chancellery Building, Universiti Sains Malaysia, 11800 USM, Pulau Pinang, Malaysia (hereinafter referred to as the **SECOND PARTY**).

The FIRST PARTY and the SECOND PARTY are here in after collectively referred to as the PARTIES.

In order to develop Human Resources and to utilize Information and Communication Technology within the **PARTIES**' environment, the **PARTIES** hereby agree to enter into this Memorandum of Understanding (MoU) under the following terms and conditions:

#### **ARTICLE 1**

#### **PURPOSE**

- 1. To enhance the cooperative relationship between the **PARTIES** in conducting activities related to Education, Research, and Community Service.
- 2. To support Institutional Development, Improvement of Higher Education Quality, and Enhancement of Work Programs for both **PARTIES**.

#### **ARTICLE 2**

#### **SCOPE OF ACTIVITIES**

The scope of cooperation under this MoU covers the implementation of the Three Pillars of Higher Education (Tri Dharma), including:

- 1. Education;
- 2. Research: and
- 3. Community Service (PKM)

#### **ARTICLE 3**

#### **RESPONSIBILITIES AND OBLIGATION**

- 1. The **PARTIES** shall be jointly responsible for coordinating the implementation of activities aimed at enhancing human resources competencies.
- 2. The **PARTIES** shall coordinate in providing the necessary human resources according to the mutually agreed activity requirements.
- 3. Specific duties and responsibilities for each activity shall be detailed and mutually agreed upon in a separate Cooperation Agreement (PKS) or supporting document.

#### **ARTICLE 4**

#### **DURATION**

This MoU shall remain valid for five (5) years, effective from the date of signing and may be extended upon mutual agreement of the **PARTIES**.

#### **ARTICLES 5**

#### POSITION AND NON-EXCLUSIVITY

During the term of this MoU, the **FIRST PARTY** shall not be exclusively bound the **SECOND PARTY** and may establish similar cooperation agreements with other institutions of entities engaged in the same or similar fields.

#### **ARTICLES 6**

#### **FINANCING**

All costs incurred in the implementation of this MoU shall either be stipulated in a separate Cooperation Agreement (PKS) or borne by each **PARTY** according to mutual agreement.

#### **ARTICLES 7**

#### **CLOSING PROVISIONS**

1. This MoU is made in good faith by both **PARTIES** and shall be implemented in accordance with the regulations and policies applicable to each institution, with the aim of supporting the execution of institutional tasks and functions optimally.

- 2. A change in leadership or management of either **PARTY** shall not affect the validity of this MoU for the duration of its agreed validity period.\
- 3. Termination of this MoU shall be carried out by either **PARTY** if fundamental differences arise in its implementation, provided that a written notice is given at least one (1) month prior to termination.
- 4. This MoU is made in two (2) original copies, duly stamped, signed, and legally binding, with each **PARTY** holding one copy.
- 5. Any matters not yet regulated in this MoU shall be subsequently arranged in an addendum, which will form an integral part of this MoU.

Thus, this Memorandum of Understanding is made and agreed upon by both **PARTIES** as the primary basis for establishing sustainable cooperation.
